# Chevy, OnStar Quick to Aid Superstorm Sandy Relief

Only hours after Hurricane Sandy lashed the Eastern seaboard and surrounding states, Chevrolet announced a donation of 50 Silverado full-size pickup trucks and Express cargo vans to the American Red Cross to use in relief and recovery efforts.

OnStar also donated 300 minutes of hands-free cellular and three months of its Directions and Connections plan, including turn-by-turn navigation services, to each of the vehicles. The donated vans and trucks are being pulled from existing inventory at dealerships closest to where they are needed, ensuring they'll arrive in disaster areas quickly.

Additional aid in the amount of \$250,000 was donated by the GM Foundation to the Red Cross Disaster Responder Program. Like the trucks, vans and OnStar navigation services, this donation was made to help immediate rescue and relief efforts.

The money will be used to feed emergency crews, feed and shelter evacuees, and provide blood and related products to those injured by the storm.

Commenting on Chevrolet's commitment to the ongoing recovery and relief effort, GM Chairman and CEO Dan Akerson said, "It is during disasters like this that we all need to pull together as a country and Chevrolet has a role in that.'

He added, "Making these vehicles available quickly where they can do the most good is something we can do right now.'
